Whilst we will email booking contacts of any changes, it is your responsibility to check the latest Terms and Conditions prior to use. These will be available on our website.

### **Method of Hire**

Requests for the use of the AWP or grass pitches should be by email to [info@go-underhill.com](mailto:info@go-underhill.com)

- The request is not confirmed until the hirer receives confirmation from UMC Ltd.
- UMC reserves the right to refuse an application without stating the reason.

### **Payments**

All hirers of the must pay for their hire 72 hours in advance of use, failure to do so may result in the booking being allocated to another user.

- Where a customer is invoiced, the methods of payment will be indicated.
- No booking can be confirmed until the required payment is received, except where agreements are in place for instalment payments.
- UMC Ltd reserves the right to amend the scale of charges at any time without prior notice.

### **Cancellation**

UMC will avoid cancellations whenever possible and will only be made in the event of weather or other events beyond our control. The Hirer shall not be entitled to any compensation in consequence thereof or in connection therewith.

### **Use of Facilities**

You must adhere to the following Terms and Conditions at all times.

- All persons using facilities hired shall behave in a manner that does not cause injury, damage or nuisance to property, staff or other users of the park or ground.

- All persons shall conform to UMC Terms and Conditions and comply with any instructions they may receive from UMC staff.
- No spectators allowed within the AWP fencing.
- Only permitted footwear – rubbers studs and astroturf footwear is allowed on the AWP, trainers, metal studs and blades are not allowed. The hirer will be responsible for all players using the pitch and will be liable to pay for any damage to the playing surface.
- The hirer will be responsible for wilful or negligent damage caused to the pitch, equipment, building, fences or any other of UMC's property by their own members, or the members of a club against whom they are playing.
- The hirer must ensure that they treat the facilities in a proper manner i.e., no washing of boots in showers, kicking of footballs in buildings or leaving litter e.g. drinks cans, sweet wrappers etc. Glass bottles or glass in any form must not be taken into the changing facilities or onto the AWP or grass areas at any time.
- A charge may be levied on changing rooms if additional cleaning is required.
- Smoking, chewing gum, food or drink is not permitted inside the fenced area. Bottled water (in plastic containers) is permitted.
- Public liability insurance is compulsory for all clubs. The insurance must cover clubs for public liability claims arising from the use of the facilities, which are the subject of a hiring agreement. The minimum liability cover must be 5 million pounds.
- UMC Ltd shall not be liable for the death or injury to, or damage to, or any expenses or other liability incurred by the hirer or any person in the exercise of this agreement.
- All hirers must comply with our equal opportunities policy wherein they do not exercise any discrimination on the grounds of race, nationality, colour, ethnicity, age, sex, marital status, sexual orientation, religion, or disability.
- Failing to comply with any of these conditions the hirer will be liable to forfeit the use of the AWP facility without any adjustment of fees in respect thereof, such forfeiture to be without prejudice to any other claims or remedies which UMC Ltd may have against the hirer.
- Cars are not allowed to park by the Hub, only in the designated car park.
